CFUW Markham-Unionville Acknowledgement of Risk & Waiver

I, the undersigned member of the Canadian Federation of University Women Markham—Unionville (the “Club”), acknowledge and agree as follows:

Activities

I acknowledge that the Club offers many interest group activities to its members (the “Activities”). The Club’s Activities include:

- (a) Active: Active lifestyle programming, including yoga led by a certified instructor, golf at local courses, cycling, and walks or hikes on public trails. The facilitators of such activities may require additional waivers.
- (b) Advocacy: Discussions about CFUW National advocacy resolutions and the Club’s local advocacy initiatives, hosted online or at a member’s home.
- (c) Arts: Arts programming, including film and writing circles, knitting/crochet groups, photography tours, and outings to local art events (ex. theatre).
- (d) Book Clubs: Books discussion with refreshments hosted online or at a member’s home.
- (e) Games: Card games or board games hosted online or at a member’s home.
- (f) Language: Conversational programming online or at a member’s home.
- (g) Social: Meals, wine tastings, and other similar events, at a restaurant or at a member's home
- (h) Other: Other activities of interest to the members hosted online, at a member’s home, or at another meeting place arranged by the Club.

Acknowledgement and Assumption of Risk

I understand and am aware that my participation in the Activities may involve inherent risks or hazards, whether caused by my actions, inactions, or negligence, that of others, or the conditions of the environment in which the Activities occur. I voluntarily and freely assume all risks and hazards that may occur pursuant to my participation in the Activities, including risk of injury, death, or damage to property, regardless of their cause.

Waiver, Release, and Indemnification

I hereby release the Club, its directors, members, volunteers, agents, and any other affiliates (collectively, the “Group”) from all present and future claims that may be made by me, my family, estate, heirs, or assigns for injury, property damage, or death arising as a result of my participation or involvement in any and all Activities of the Club. I agree to indemnify and hold harmless the Group from all claims, losses, liabilities, damages, expenses, and costs arising out of my participation in the Activities.

Requirement to Participate in Activities

I acknowledge that agreeing to this waiver of liability is required as a condition to my participation or involvement in any and all activities hosted by the Group.

Requirement to Host Activities

I acknowledge that if I elect to host an Activity on my personal property, or in my personal capacity, the Club requires that I subscribe for and maintain a personal liability insurance policy of at least \$1,000,000.

I have read and understood this waiver. I understand that the Group is not responsible for any personal injury or property damage arising out of my participation in the Activities. I understand that it is intended to be as broad as is permitted by law. I agree that if any portion of this Agreement is invalid, the remainder will continue in full legal force and effect.
